### **Emergency Shelter**

#### *Watauga County*

- **Hospitality House – Boone, NC** – Emergency Shelter for 7-county region (Alleghany, Ashe, Avery, Mitchell, Watauga, Wilkes, and Yancey Counties), for up to 24 individuals each night; Location: 338 Brook Hollow Rd, Boone, NC; Contact 828-264-1237.

#### *Wilkes County*

- **Catherine H. Barber Memorial Shelter – North Wilkesboro, NC** – Provides emergency shelter for up to 14 nights per year; open 6:30 pm to 6:30 am; Individuals may need transportation due to location. Location: Hwy 18 North, North Wilkesboro, NC; Contact 336-838-7120.

#### *Ashe County*

### **Transitional Housing**
